Registered teachers

This fact sheet provides information as to when registered teachers require an exemption card under the *Working with Children (Risk Management and Screening) Act 2000* (the Act).

Fact sheet

When do teachers need an exemption card?

Teachers registered with the Queensland College of Teachers do not require a blue card or exemption card when teaching at a school or boarding school.

However, they may require an exemption card when providing child-related regulated services outside of their teaching role. This may include private tutoring children, working in a child care centre, volunteering at a children's sporting club, participating in a home stay or reading program or supervising after hours school care.

Once an application for an exemption card is received, Blue Card Services will liaise with the Queensland College of Teachers to confirm the applicant is a registered teacher and whether further employment screening is required.

If a teacher has a criminal history that requires a further assessment of their eligibility, Blue Card Services may request further information.

Important things to know about exemption cards

As of 31 August 2020:

- All exemption cards have a three (3) year expiry date.
- Existing exemption cards will remain valid for three (3) years until 31 August 2023 (grace period), unless it is suspended or cancelled by Blue Card Services earlier (e.g. due to a change in police information or at the applicant's request).
- Exemption cards will have a photograph of the card holder.
- Registered teachers can commence providing child-related regulated services once an <u>Exemption card</u> <u>application</u> has been made or the organisation has informed Blue Card Services they have employed an existing exemption card holder by using the online <u>Organisation Portal</u> or submitting a <u>Link an</u> <u>applicant/cardholder to this organisation</u> form to Blue Card Services.
- Exemption cards are not subject to *No Card, No Start*, so registered teachers who require an exemption card may engage in regulated employment whilst waiting for an exemption card to be issued.
- It is the organisation's responsibility to check the person's exemption card against other identification to certify that it belongs to that person.

What happens if I don't apply for a new exemption card?

If an existing card holder does not apply within the grace period, their card will be automatically cancelled.

Frequently asked questions

These scenarios are commonly asked, and are provided as a guide only and details some common scenarios for teachers. For further information about the requirements and whether an exemption applies, please contact us.

I am a teacher who regularly participates in the school's home stay program.

You will need an exemption card. When completing the <u>Exemption card application</u>, please select the 'Child accommodation services including home stays' category and nominate the school as the employer.

I am a teacher employed by the school but in a role other than teaching.

I am a teacher and undertake other regular paid work or volunteer with another organisation. For example, coaching at a children's sports club.

No, you do not need an exemption card.

You will need an exemption card. Please speak to your club or association (i.e. the sports club you coach at).

I am a teacher at a school and am also on the board of an entity which operates the Outside Hours School Care facility.

Yes, you do need an exemption card. When completing the <u>Exemption card business</u> (EB) application, please select the 'Education and care services and similar employment' category on the form and nominate the OHSC in the organisation's details section.

I am a teacher and also privately tutor students and am paid directly for this service.

Yes, you do need an exemption card. When completing the <u>Exemption card business (EB)</u> <u>application</u>, please select the 'Private teaching, coaching or tutoring' category. You can nominate your own name or your registered business name in the organisation's details section.

I am a teacher at a school and I also regularly supervise the Outside Hours School Care program.

You will need an exemption card. When completing the <u>Exemption</u> <u>card application</u>, please select the 'Education and care services' category and nominate the OHSC as the employer.

I teach at a school and do no other childrelated activities

No, you do not need an exemption card.

I am a teacher at a non-state school and a director of the school's governing body under the *Education (Accreditation of Non State Schools) Act 2001.*

Yes, you do need an exemption card. When completing the <u>Exemption card business (EB)</u> application, please select 'Director of a corporation which is the governing body for a provisionally accredited, or accredited, non-state school' category. Individuals need to have the exemption card before they can start.
